Merdeka Homes Ltd and its Directors ("Company", "we", "us", or "our") are committed to protecting your personal information and your right to privacy. When you visit our websites <u>https://www.myrunswickbay.co.uk</u> and more generally, use any of our services (the "Services", which include our Tailormade Packages on the Websites), we appreciate that you are trusting us with your personal information. This privacy notice applies to all information collected, as well as any related Services, marketing, or events. Please read this privacy notice carefully as it will help you understand what we do with the information that we collect.

#### WHAT INFORMATION DO WE COLLECT AND HOW DO WE COLLECT IT?

In Short:

- We collect information (full name, address, postcode, email address, telephone or mobile number) that you provide to us through email, website or social media.
- We collect personal information that you voluntarily provide to us when you express an interest in obtaining information about us or our products and Services, when you participate in activity on the Website or otherwise when you contact us.

#### Information automatically collected

In Short:

Some information — such as your Internet Protocol (IP) address and/or browser and device characteristics — is collected automatically when you visit our Website. We automatically collect certain information when you visit, use, or navigate the Website.

This information does not reveal your specific identity (like your name or contact information) but may include device and usage information, such as your IP address, browser and device characteristics, operating system, language preferences, referring URLs, device name, country, location, information about how and when you use our Website and other technical information.

This information is primarily needed to maintain the security and operation of our Website, and for our internal analytics and reporting purposes.

We use the information we collect or receive:

To post testimonials.

- To respond to legal requests and prevent harm. If we receive a legal request, we may need to inspect the data we hold to determine how to respond.
- Fulfil and manage your payments. We may use your information to fulfil and manage your payments or cancellations made through our online booking system.
- To send you marketing and promotional communications or administer prize draws and competitions.
- We may use your information to administer prize draws and competitions when you elect to opt-in to our marketing or sign up to our monthly newsletters. You can opt-out of our marketing emails at any time.
- To respond to user enquiries/offer support to users.
- We may use your information to respond to your enquiries and solve any potential issues you might have with the use of our Services.

# WILL YOUR INFORMATION BE SHARED WITH ANYONE?

# In Short:

We only share information with your consent, to comply with laws, to provide you with services, to protect your rights, or to fulfil business obligations. We may process or share your data that we hold on the following lawful bases:

- Your consent:
  - We may process your data if you have given us specific consent to use your personal information in a specific purpose.
- We have a legitimate interest:
  - We may process your data when it is reasonably necessary to achieve our legitimate business interests.
- Contractual obligation:
  - Where we have entered a contract with you, we may process your personal information to fulfil the terms of our contract.
- Legal obligation:
  - We may disclose your information where we are legally required to do so to comply with applicable law, governmental requests, a judicial proceeding, or legal process such as in response to a court order (including in response to public authorities to meet national security or law enforcement requirements).
- We have a vital interest:
  - We may disclose your information where we believe it is necessary to investigate, prevent, or act regarding potential violations of our policies. Our Websites may contain links to other websites of interest. However, once you have used these links to leave our site, you should note that we do not have any control over that other website. Therefore, we cannot be responsible for the protection and privacy of any information which you

In Short:

We only share information with the following third parties.

- Website Usage Google Analytics

We may need to process your data or share your personal information in the following situation:

 Vendors, Consultants and Other Third-Party Service Providers. We may share your data with third-party service providers or agents who perform services for us or on our behalf and require access to such information to do that work. Eg: payment processing, data analysis, email delivery, third party activity partners for our Tailormade Packages, customer service or marketing efforts. Unless described in this notice, we do not share, sell, rent, or trade any of your information with third parties for their promotional purposes.

DO WE USE COOKIES AND OTHER TRACKING TECHNOLOGIES?

In Short:

- We may use cookies and other tracking technologies to collect and store your information.
- We may use cookies and similar tracking technologies to access or store information. Specific information about how we use such technologies and you can refuse certain cookies.

## HOW LONG DO WE KEEP YOUR INFORMATION?

## In Short:

We keep your information for as long as necessary to fulfil the purposes outlined in this privacy notice unless otherwise required by law. No purpose in this notice will require us keeping your personal information for longer than necessary according to GDPR guidelines. When we have no ongoing legitimate business need to process your personal information, we will either delete or anonymise such information.

# HOW DO WE KEEP YOUR INFORMATION SAFE?

## In Short:

We aim to protect your personal information through a system of organisational and technical security measures. We have implemented appropriate technical and organisational security measures designed to protect the security of any personal information we process. Although we will do our best to protect your personal
